ABOUT CENTRAL UNIVERSITY OF HARYANA



Central University of Haryana is one of the fifteen new Central Universities established by the Ministry of Human Resource Development, Government of India (GoI) in the XI Five Year Plan (2007-2012) under the Central University Act-2009 of the Parliament. The university has been accredited with an 'A' grade in the second cycle of NAAC assessment and accreditation conducted in August 2023. Text should be printed in Times New Roman with font size 12 typed in 1.5 line spacing on an A4 paper layout with standard margins (2.54 cm) on all four sides. The Best Paper award will be conferred on the most outstanding paper.

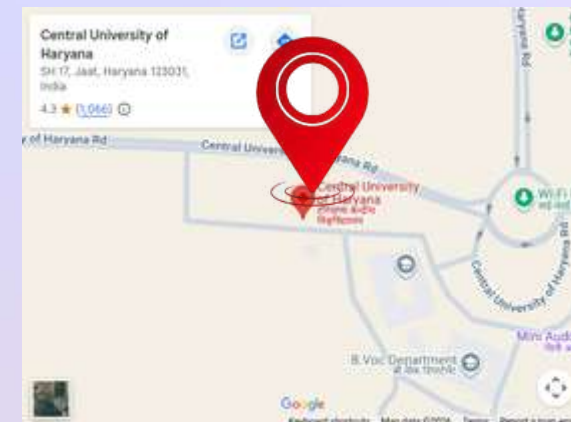

HOW TO REACH CENTRAL UNIVERSITY OF HARYANA:

If you are coming from Delhi or Gurgaon (distance-125 kms.), come through NH-08 and after crossing. Dharuhera, turn right for Rewari, and then take the Mahendergarh road, and after reaching Mahendergarh, travel 8 kms towards Charkhi Dadri, and then you will find CUH Gate No. 1 on the road. From there, you can reach the University Academic Blocks & Administration Block. If you are coming from Jaipur (Distance-190Kms.), then reach Mahendergarh via Behror and Narnaul.

1. Baba Hanuman Mandir, Khalda

The temple is dedicated to Lord Hanuman and located on Narnaul-Singhana road surrounded by Aravali hills.



2. Jal Mahal

Palace structure built in the center of a pond by Shah Kuli Khan.



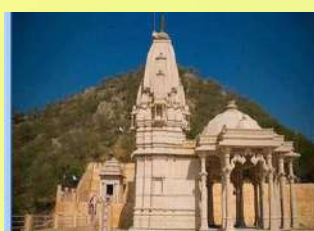
3. Temple at Dhosi Hill
