2. The honorarium will be paid @ Rs. 750/- per lecture of one hour subject to the ceiling of remuneration Rs. 30,000/- in a calendar month in case of NET/Ph.D. and Rs. 35,000/- in case of NET+Ph.D.
3. The cut-off date for eligibility is the date of interview.
4. The preparation of panel is not an appointment/engagement of any job in the University and the selected/empanelled candidate shall not entitle for any other benefits as applicable to regular teachers of the University. This should be treated as purely stop gap arrangement for the session 2026-27.
5. Other conditions/duties shall be decided by the University and remain as binding. In case of any doubt/dispute regarding any condition, the matter will be referred to the Vice Chancellor whose decision shall be final.
6. The eligible interested expert persons/candidates are called to attend the walk-in-interview alongwith CV and original documents and self attested copies of testimonials on the scheduled day **(to be notified on the website soon)**.
7. Courses/Subjects where NET examination is not conducted UGC rules will prevail.
8. The selected/empanelled candidate(s) will be called as and when need is felt.
